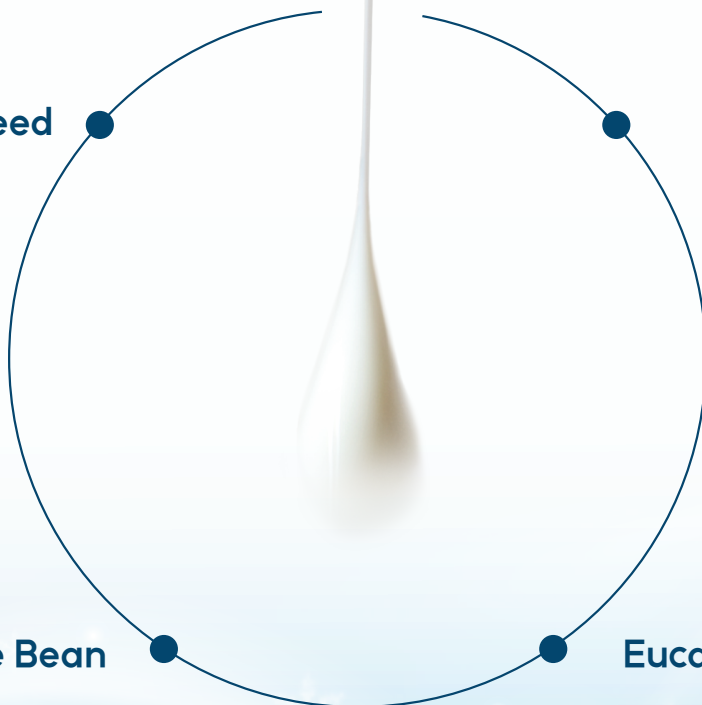

CLINICAL TEST AND CERTIFICATION

This test, commissioned by Nexus Pharma Co., Ltd., evaluated the UVA Protection Factor (PFA) and the Protection Grade of UVA (PA) of [Glutanex Glow Sun Cream Light]. The results confirmed a PFA of 16.8 ± 2.4 and a PA rating of +++++.

This test product showed a skin irritation index of 0.00.

Human Skin Clinical Trial Center Co., Ltd. faithfully conducted this test, commissioned by Nexus Pharma Co., Ltd., in accordance with the GCP (Good Clinical Practice) guidelines, the regulations of ISO 24444:2019/Amd1:2022 "Cosmetics – Sun protection test methods – In vivo determination of SPF (sun protection factor)," and the standard operating procedures (SOP) of the Human Skin Clinical Trial Center Co., Ltd. The results are reported as follows:

Based on the results of the preliminary assessment, the test was conducted with 10 subjects. The SPF of standard sample P8 was 65.0 ± 7.4 , that of standard sample P2 was 16.6 ± 2.5 , and the SPF of the test product was confirmed as 52.8 ± 5.4 (see Table 16).
